

## Photo identification

We have introduced a new step in the procedure for the replacement of authorisation/licence cards. You will need to show us acceptable identification in order for us to confirm your identity.

### Why do I have to provide identification?

Requiring identification helps to prevent people obtaining cards fraudulently and to maintain the integrity of our licensing system.

### Confirm your identity

When completing an application for the replacement of a lost card you must now present a **certified** copy of either:

- your New Zealand Driver's Licence (current or expired up to two years); **or**
- your New Zealand Passport (current or expired up to two years).

### What is a **certified** copy?

A certified copy of a document is one that has been officially declared to be correct. This can be done by taking the original document and a good quality photocopy of it to a lawyer, Justice of the Peace or Court Registrar.

The lawyer, Justice of the Peace, or Registrar will check the photocopy against the original and then sign the photocopy to say they certify it as a true and correct copy of the original.

## What if I don't have a Driver's Licence or Passport?

If you do not hold a New Zealand Driver's Licence or Passport, you must provide **certified** copies of one primary document and one secondary document from the tables below. At least one of these documents must include a photograph of you.
