

## Guidance notes for *Journeyman* registration

### What is the *Journeyman* class of registration?

The *Journeyman* class is for those plumbers, gasfitters and drainlayers who have not passed the Boards relevant licensing exam but have completed one of the following qualifications:

- the *National Certificate* (this came into effect in 1998) **or**
- *Trade Practice Certificate* (this applied before 1998) **or**
- the 3rd stage block course (this applied before 1998).

### Why was the *Journeyman* class of registration created?

There are a number of people working in the industry who have completed a trade qualification but, for a variety of reasons, haven't passed their theory exam. Rather than having these people work under *exemptions under supervision*, the *Journeyman* class recognises that these people have some formal training and allows them to register and licence as a *Journeyman* in their trade.

### When does the *Journeyman* class come into effect?

From 6 December 2016.

### What authorised work can a *Journeyman* do?

A registered and licensed *Journeyman* can install, and work under the supervision of their *Certifier*. Unlike *exemption under supervision* holders, however, there is no requirement that they work under the direct supervision of their *Certifier* during the first two years.

The restricted work carried out by a *Journeyman* is not subject to mandatory testing by their *Certifier* or nominated person (unlike *exemption under supervision* holders); although testing of the work (or direct supervision) might still be deemed appropriate by their *Certifier* in certain circumstances.

A *Journeyman* gasfitter is entitled to work on live gas, under the supervision of their *Certifier* (unlike *exemption under supervision* holders).

A *Journeyman* cannot be a nominated supervisor, nor can they verify, or, in the case of gasfitting, commission or issue gas certificates. For the complete legislation, see the relevant Gazette notice: <http://www.pgdb.co.nz/legislation-policies/legislation.html>

### What does it cost to register?

**Zero fees apply until 6 December 2018.** The Registrar has waived the fees if you apply for registration and a practising licence prior to 6 December 2018. This means you will not pay to be registered and you also won't pay any licence fee for what remains of the 2018 licensing year. If you apply to register after 6 December 2018, standard registration fees will apply of between \$441 and \$712 (depending on how many trades you are registering in).

### How much will the annual licensing fee be?

Based on the current fees it will cost \$357 for one *Journeyman* trade, \$443 for two *Journeyman* trades and \$529 for three *Journeyman* trades.

### Will I have to do the CPD course each year to renew my licence?

Yes. CPD information can be found on the Board's website: <http://www.pgdb.co.nz/trade/cpd.html>

- Your application will be processed within 10 working days of receipt.
- Registration rounds take place fortnightly. Your registration will be entered into the public register that day and you will receive your registration certificate within 10 working days. If you have applied for a licence, you will receive your card within 10 working days.

## PART 2 – Qualifying standards for registration as a Journeyman Gasfitter

Attach a **certified copy** of either your:

- NZQA “National Certificate in Gasfitting” (1998 onwards)
- NZQA “Result Pass” of 3<sup>rd</sup> stage block course in gasfitting (before 1998)
- NZQA “Practice Trade Certificate in Gasfitting” (before 1998)



- **How do I get evidence of my National Certificate/Practice Trade Certificate/3<sup>rd</sup> stage?**

Contact the New Zealand Qualifications Authority (NZQA) on 0800 697 296. Their Tertiary Records section will be able to send you a National Certificate copy or provide you with evidence of the others.

- **What is a certified copy?**

A certified copy of a document is one that has been officially declared to be correct by a person able to make a declaration under the Oaths and Declarations Act 1957. This can be done by taking the original document and a good quality photocopy of it to either a:

- ✓ a lawyer, or
- ✓ Justice of the Peace, or
- ✓ Court Registrar.

They will check the photocopy against the original, and then sign the photocopy to say they certify it as a true and correct copy of the original. This service is usually free of charge.

- **How do I find a lawyer, or a Justice of the Peace, or a Court Registrar?**

Use Google to find a lawyer or JP near you, or your nearest Court. Court Registrars are at your local court house. JP's are also listed in your local White Pages.

- **Why don't you recommend police officers?**

Not a lot of police officers are able to make declarations under the Oaths and Declarations Act 1957. All lawyers, JP's, and Court Registrars can make the declaration.

- **Should I supply my Certificate of Due Completion (i.e. pre-1998 hours)?**

No. The requirement for Journeyman registration is based on your trade qualification, not hours.

**OR**

- have had a section 52 exemption approved by the Board.

## PART 4 – Application for a 2018 practising licence and supervision

- I may only carry out gasfitting work under the supervision of my *Certifying Gasfitter* supervisor below, or a “nominated supervisor” that my *Certifier* nominates
- I may carry out testing of gasfitting, unless it is for the purposes of verifying compliance under the Building Act 2004 and/or the Gas Act 1992;
- My name, registration type and licensing information will be listed on my online public register page. My name and licence type will also be listed on my supervisor’s online public register page; and
- At all times when undertaking gasfitting I must be able to produce my current licence card on demand.

**Supervisor (Certifying Gasfitter):**

By signing this form, you agree to comply with your responsibilities as a supervisor and understand that:

- You must ensure that gasfitting undertaken by the applicant
  - a) Is performed competently;
  - b) Is subject to appropriate safety measures; and
  - c) Complies with the requirements of all relevant regulations, including regulations made under the Building Act 2004 and the Gas Act 1992.
- You must ensure that the applicant
  - a) Is competent to perform the tasks undertaken;
  - b) Is adequately supervised while carrying out gasfitting;
  - c) Complies with all relevant regulations, including regulations made under the Building Act 2004 and the Gas Act 1992; and
  - d) Can produce their current authorisation card on demand.
- You may nominate another currently licensed *Certifying Gasfitter* or *Tradesman Gasfitter* (“nominated person”) to provide physical supervision of the applicant. You remain responsible at all times for all aspects of the work done by the applicant even where you have nominated another *Certifying Gasfitter* or *Tradesman Gasfitter* to provide physical supervision of that work.
- You must verify work where verification is required.
- You must notify the Board in writing if your supervision of the applicant ceases. You remain responsible for all gasfitting undertaken by the applicant under your supervision until the Board has received written notice that you are no longer supervising that person, or until their licence expires.
