

# Tradesman Plumber registration (and a practising licence)

## *2018 licensing year (expires 31 March 2019)*

### Notes

- As of 6 December 2016, the registration class previously known as “licensed” is now called “tradesman”.
- Your application will be processed within 10 working days of receipt.
- Registration rounds take place fortnightly. Your registration will be entered into the public register that day and you will receive your registration certificate within 10 working days. If you have applied for a licence, you will receive your card within 10 working days.
- If you have any questions about this form please call the registration team between 8am-5pm, Monday to Friday on 0800 743 262 (on the options menu press 2).

### The criminal record(s) requirement

Our industry plays an essential part in safeguarding public health and safety, and the legislation requires the Board to be satisfied that a person is fit and proper before it issues them with a registration.

Under the Act, we must be satisfied that people are fit and proper every time they apply to be registered. Apart from criminal conviction information, there is little we can do to satisfy this legislative requirement.

Therefore, when registering with the Board, please note that copy of your criminal record is a requirement for registration at Journeyman level, Tradesman level, or Certifying level.

In reality, there are not many convictions that would prevent a person from being registered at any of the three levels. This is because most convictions aren't relevant to whether a person can do their job as a plumber, gasfitter, or drainlayer.

However, there are some convictions that might mean a person isn't fit and proper. For instance, if a person had a large number of theft and burglary convictions that may well be relevant to whether or not they should be registered and allowed into people's homes.

Your record is available from the Ministry of Justice (<http://www.justice.govt.nz/criminal-records/get-your-own/>) within 10-20 working days.

- **Do I need to supply evidence of my exam pass?**

No, unless you passed your exam more than 13 years ago. If you passed the exam before 2005, contact the New Zealand Qualifications Authority (NZQA) on 0800 697 296 and get a copy of your result. Get a certified copy and attach it to this form (see certified copy information below).

**AND**

- National Certificate in Plumbing issued by the New Zealand Qualifications Authority.

- **Do I need to attach a certified copy of my NZQA National Certificate?**

Yes.



- **What is a certified copy?**

A certified copy of a document is one that has been officially declared to be correct by a person able to make a declaration under the Oaths and Declarations Act 1957. This can be done by taking the original document and a good quality photocopy of it to either a:

- ✓ a lawyer, or
- ✓ Justice of the Peace, or
- ✓ Court Registrar.

They will check the photocopy against the original, and then sign the photocopy to say they certify it as a true and correct copy of the original. This service is usually free of charge.

- **How do I find a lawyer, or a Justice of the Peace, or a Court Registrar?**

Use Google to find a lawyer or JP near you, or your nearest Court. Court Registrars are at your local court house. JP's are also listed in your local White Pages.

- **Why don't you recommend police officers?**

Not a lot of police officers are able to make declarations under the Oaths and Declarations Act 1957. All lawyers, JP's, and Court Registrars can make the declaration.

**OR**

- You have an overseas plumbing qualification that has been accepted by the Board.

**OR**

- You have had a section 52 exemption approved by the Board from one of the previous qualifying standards.

Your supervisor must be registered in the certifying class and **hold a current licence** for the 1 April 2018-31 March 2019 licensing year before your application can be processed.

I understand that:

- I may only carry out sanitary plumbing work while holding a current licence and under the supervision of my *Certifying Plumber* supervisor below, or a “nominated supervisor” that my *Certifier* nominates
- I may carry out testing of sanitary plumbing, unless it is for the purposes of verifying compliance under the Building Act 2004
- I may physically supervise, as a “nominated person”, sanitary plumbing undertaken by a person under supervision
- If I am a “nominated supervisor” and provide physical supervision of a person I must promptly notify the person’s supervising Certifying Plumber of any concerns I have about the competency of the work done by that person or the safety measures in place in respect of the work done by that person
- My name, registration type and licensing information will be listed on my online public register page
- My name and licence type will be listed on my supervisor’s online public register page.
- At all times when undertaking sanitary plumbing I must be able to produce my current licence card on demand.

**Supervisor (Certifying Plumber):**

By signing this form, you agree to comply with your responsibilities as a supervisor and understand that:

- You must ensure that sanitary plumbing undertaken by the applicant
  - a) Is performed competently;
  - b) Is subject to appropriate safety measures; and
  - c) Complies with the requirements of all relevant regulations, including regulations made under the Building Act 2004.
- You must ensure that the applicant
  - a) Is competent to perform the tasks undertaken;
  - b) Is adequately supervised while carrying out sanitary plumbing;
  - c) Complies with all relevant regulations, including regulations made under the Building Act 2004; and
  - d) Can produce their current licence card on demand.
- You may nominate another currently licensed *Certifying Plumber* or *Tradesman Plumber* (“nominated person”) to provide physical supervision of the applicant. You remain responsible at all times for all aspects of the work done by the applicant even where you have nominated another *Certifying Plumber* or *Tradesman Plumber* to provide physical supervision of that work.
- You must verify work where verification is required.
- You must notify the Board in writing if your supervision of the applicant ceases. You remain responsible for all sanitary plumbing undertaken by the applicant under your supervision until the Board has received written notice that you are no longer supervising that person, or until their licence expires.
