

Application for Registration and Practising Licence as a Licensed Plumber 31 July 2010 - 31 March 2011

PLEASE READ CAREFULLY

This application is for:

1. Registration as a Licensed Plumber under section 37 of the Plumbers, Gasfitters, and Drainlayers Act 2006 ("the Act"); and
2. Practising licence as a Licensed Plumber under section 45 of the Act.

Requirements

1. Please **complete the attached application form** and return it to this office with;
2. **Verified copies of the required documents** as listed in **one** of the following options. Documents **must be verified** by a Justice of the Peace or a person authorised to take an oath or declaration such as a Barrister or Solicitor, Notary Public, Registrar of the Court or other officer authorised to take Statutory Declarations (e.g. sworn Police Officers). **DO NOT SEND ORIGINALS.**

If you completed your training prior to 1998

- examination results A191 and B192 for plumbing
- evidence of completion of apprenticeship
- evidence of having achieved a pass in the third stage plumbing practical block course

If you completed your training from 1998 to July 2002 (inclusive)

- National Certificate in Plumbing (DO NOT SEND ORIGINAL)

If you completed your training from August 2002 to present

- National Certificate in Plumbing (DO NOT SEND ORIGINAL)
- pass in examination 9192 Licensed Plumber (see Note on Page 2)

If you have held a limited certificate for a continuous period of 5 years

- examination results 9192 Licensed Plumber
- practical test of workmanship results form from the assessment centre
- evidence of having held a limited certificate for a continuous period of 5 years

If you have held a limited certificate in plumbing continuously for 3 or more years, followed by an exemption under supervision for a continuous period of 2 years (this provision ceases on 31 March 2012)

- examination results 9192 Licensed Plumber
- practical test of workmanship results form from the assessment centre
- evidence of having held a limited certificate for a continuous period of 3 or more years, followed by an exemption under supervision for a continuous period of 2 years

If you are an Overseas Applicant who has had their qualifications recognised by the Board

- examination results 9192 Licensed Plumber
- practical test of workmanship results form from the assessment centre

If you are a Licensed Gasfitter seeking registration as a Licensed Plumber

- examination results 9192 Licensed Plumber
- evidence of having achieved a pass in the third stage plumbing practical block course

Please note:

- National Certificate in Plumbing

The National Certificate in Plumbing is issued by the New Zealand Qualifications Authority (NZQA). Contact details PO Box 160, Wellington, or phone 0800 697 296.

- A pass in the Board's registration examination 9192

We require examination results for exams held before November 2005 only, as after 2005 the Board holds the results.

3. Registration Fee(s)

\$500.00 Licensed Plumber.

This fee is for processing your application and includes your practising licence for the year ending 31 March 2011 (\$100.00) and certificate of registration (\$50.00).

In addition, you must also pay the current disciplinary levy (\$266.00).

However, if **prior to 31 July 2010** you renewed any practising licence/s for the current licensing year, the \$50.00 disciplinary levy you paid for each of one or more licence(s) is deducted from the current disciplinary levy e.g. if you are a current Licensed Drainlayer, deduct \$50.00 from \$266.00; If you are a current Licensed Gasfitter and Certifying Drainlayer, deduct \$100.00 from \$266.00. Please refer over the page for more information.

If you relicensed in any trade **on or after 31 July 2010**, you are only required to pay the \$500.00 registration fee, as you will have already paid the full disciplinary levy.

Please use the Registration Fee and Disciplinary Levy Calculation Sheet on page 4.

If you do not intend to work in Plumbing after you are registered, please contact the Board before you submit this application.

All fees are inclusive of Goods and Services Tax (GST).

Board Meetings

If you meet the requirements for registration, your application will be considered by the Board at its next meeting and you will be notified accordingly. The meeting schedule is on the Registration section of the Board's website.

Change of Address

Section 76 of the Act requires a practising licence holder to notify the Registrar of their new street address within 3 months of changing address.
