 - c. Complies with all relevant regulations, including regulations made under the Building Act 2004 (and the Gas Act 1992); and
 - d. Can produce their current licence card on demand.
- 3. You may nominate another currently licensed Certifying Plumber/Gasfitter/Drainlayer (where relevant) or Tradesman Plumber/Gasfitter/Drainlayer (where relevant) (this is called a 'Nominated Person') to provide physical supervision of the applicant. You remain responsible at all times for all aspects of the work done by the applicant even where you have nominated another Certifying or Tradesman Plumber/Gasfitter/Drainlayer to provide physical supervision of that work.
- 4. You must verify (or certify for gasfitting) work where verification or certification is required.
- 5. You must notify the Board if your supervision of the applicant ceases. You remain responsible for all sanitary plumbing/gasfitting/drainlaying undertaken by the applicant until we receive written notice that you are no longer supervising that person, or until their licence expires.
