

Application – specific gasfitting exemption

Section 20 of the PGD Act 2006

Proficiency Assessment

Before applying for your Section 20 exemption you'll need to undergo a Proficiency Assessment with one of three Board-approved contractors.

Upon passing, the assessor will supply you with a certificate outlining:

- the exact gasfitting work you can carry out under your Section 20 exemption (and where relevant, that you can supervise others doing the gasfitting)
- a recommended period of time (maximum up to three years) until you need to undergo another Proficiency Assessment
- other recommendations, where relevant, depending on the required gasfitting work/competency e.g. complete 4 hours of upskilling every 12 months.

You then submit a Section 20 application (with your certificate attached) to us for processing and we'll issue your exemption for the relevant gasfitting work and time period (and where relevant, for supervisees).

For example:

February 2020	Mr. Henderson passes his Proficiency Assessment. The recommendation on his Proficiency Assessment certificate states he doesn't need to undergo another assessment for two years.
March 2020	Mr. Henderson then submits his Section 20 exemption application, we process it and he is authorised for the period 1 April 2020-31 March 2022.
February 2022	Mr. Henderson passes his Proficiency Assessment. The recommendation states he doesn't need to undergo another assessment for two years.
March 2022	Mr. Henderson then submits his Section 20 exemption application, we process it and he is authorised for the period 1 March 2022-31 March 2024.

Costs

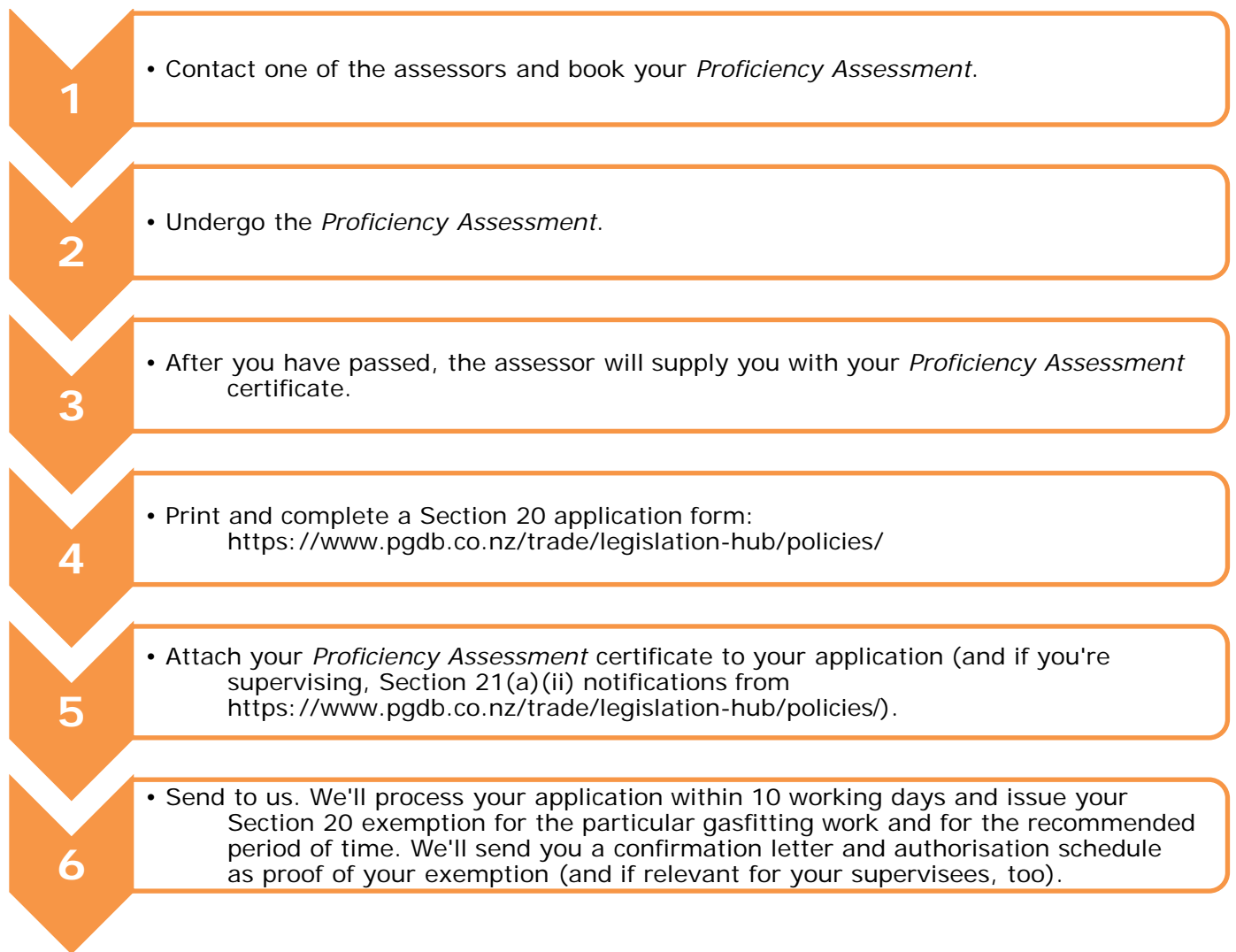
The cost of the Proficiency Assessment will be paid for by the applicant, and may vary according to the type/extent of gasfitting work you require the exemption for, and the distance the assessor has to travel to where you are located.

The Section 20 application fee stays at \$635 and can be issued for a maximum up to 3 years, depending on how long your Proficiency Assessment is valid for.
