This form is for people who carry out gasfitting work under the supervision of a Section 20 exemption holder.

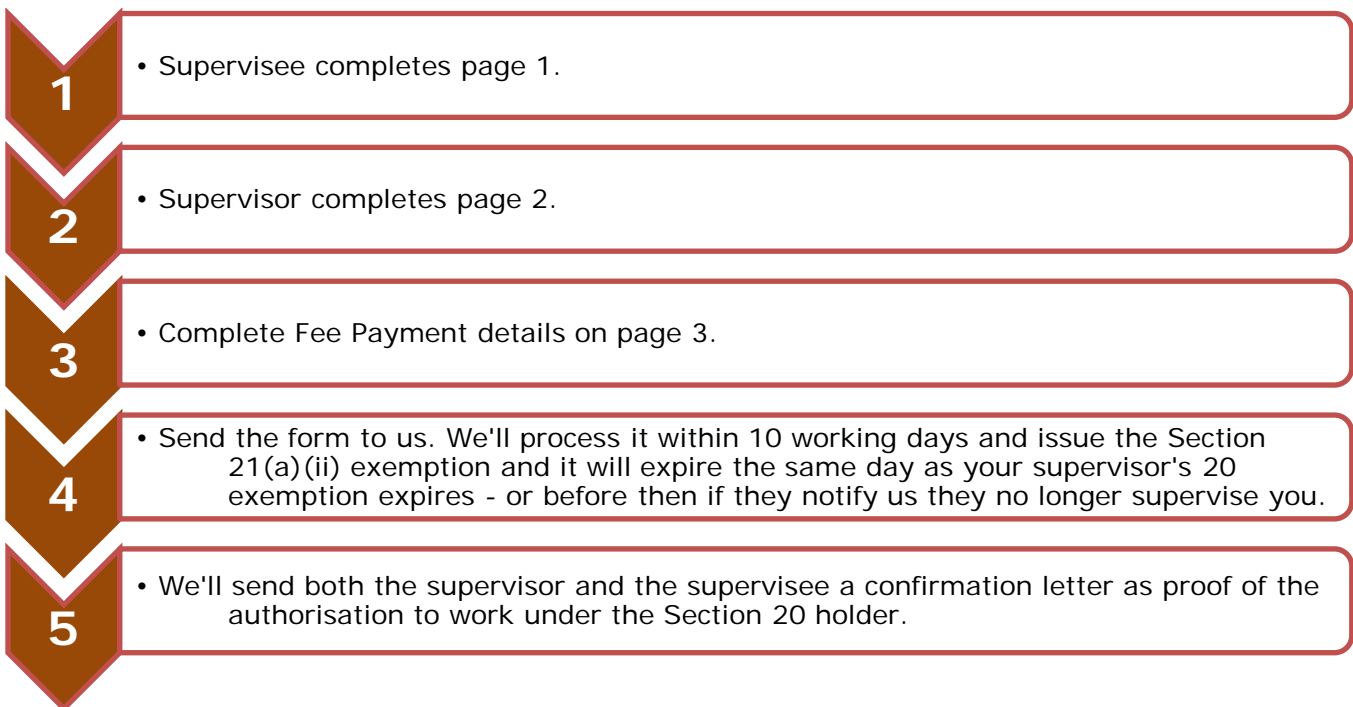
### Who completes this form?

### What gasfitting work can a person do under this Section 21(a)(ii) exemption?

You may do, or assist in doing, gasfitting work that your supervisor is authorised under Section 20 to do if-

1. The work you do is carried out under the supervision of the Section 20 holder.
2. No pipe or appliance you work on is connected to any supply of gas; and
3. The work is-
  - a. Tested and certified in accordance with regulations made under section 54 of the Gas Act 1992; and
  - b. Connected to a supply of gas by the person who supervises the work.

- 2) You must ensure that your supervisee:
  - a. Is competent to perform the tasks undertaken;
  - b. Is adequately supervised while carrying out gasfitting;
  - c. Complies with all relevant regulations, including regulations made under the Building Act 2004 and the Gas Act 1992.
- 3) You must ensure they do not work on any pipe or appliance connected to any supply of gas.
- 4) You must certify work where certification is required.
- 5) You must notify the Board in writing if your supervision ceases. You remain responsible for all gasfitting undertaken by the supervisee until the Board has received written notice that you are no longer supervising that person, or until their authorisation expires.
