

# Section 24 exemption application

This exemption allows a registered and licensed gasfitter to do limited sanitary plumbing work in relation to water heaters. It allows a gasfitter to fix or unfix, or assist in fixing or unfixing:

- o a gas water heater, or
- o any pipe that supplies, or is intended to supply, water to a gas water heater or hot water from a gas water heater to any fitting or appliance.

# What is a certified copy?

As part of your application, you must provide certified copies of certain documents. A certified copy of a document is one that has been officially declared to be true and correct by a lawyer, Justice of the Peace (JP), or Court Registrar. This service is usually free of charge.

- 1. Use Google to find a lawyer, Justice of the Peace, or your nearest courthouse for a Court Registrar. (JP's are also listed in your local White Pages).
- 2. Take the original document and a good quality photocopy of it to them.
- 3. They will check the photocopy against the original, and then sign the photocopy to say they certify it as a true and correct copy of the original.
- 4. Attach the certified copy to your application.

### Processing your application

We'll process your application within 20 working days of receiving it and inform you of the outcome.

# If your application has been returned to you


One (or more) of the things required as part of your application is missing and we can't process it – we'll tell you what you've missed.
