This form is for people who carry out gasfitting work under the supervision of a Section 20 exemption holder.

Who completes this form?

Both the supervisee and the supervisor.

What gasfitting work can a person do under this Section 21(a)(ii) exemption?

You may do, or assist in doing, gasfitting work that your supervisor is authorised under Section 20 to do if-

1. The work you do is carried out under the supervision of the Section 20 holder.
2. No pipe or appliance you work on is connected to any supply of gas; and
3. The work is-
 - a. Tested and certified in accordance with regulations made under section 54 of the Gas Act 1992; and
 - b. Connected to a supply of gas by the person who supervises the work.

- Send the form to us. We'll process it within 10 working days and issue the Section 21(a)(ii) exemption and it will expire the same day as your supervisor's 20 exemption expires - or before then if they notify us they no longer supervise you.

- We'll send both the supervisor and the supervisee a confirmation letter as proof of the authorisation to work under the Section 20 holder.

 - c. Complies with all relevant regulations, including regulations made under the Building Act 2004 and the Gas Act 1992.
- 3) You must ensure they do not work on any pipe or appliance connected to any supply of gas.
- 4) You must certify work where certification is required.
