

Original or Certified copy of Police Certificates dated within the last 6 months from any countries you have lived in for 12 months of more (whether in one visit or intermittently) in the last 10 years. Find out how to get the required Police Certificate here.

REQUIRED EVIDENCE:

With this application you must provide specific evidence of work you have done which demonstrates you have the skills, experience, and ability of the competencies required for Certifying level in the relevant trade.

Your evidence should be accurate and as specific as possible, and the letters must:

- confirm with specific details of the types of work you completed
- provide exact dates and details of the of work completed
- confirm who your supervisor was
- relate to the trade in which you are applying; and
- letters should be signed, dated and on letter head.

Other examples of evidence you can provide are:

- Letters from Council inspectors that have inspected and approved your work (use letter template as a guide).
- Compliance documentation for work you have done such as Council inspection sheets or gas safety certificates.
- Photographs of work you have done with evidence confirming you completed the work in the
- photos. Photos should be supported with a letter from an employer, supervisor, or customer.

By signing this application, you: a) verify that all information given is true and correct b) understand that you will be able to work under a Provisional Licence for up to 12 months to give you time to pass the APA and apply for registration, and that you may need to submit the APA application for processing before a Provisional Licence will be issued. c) Understand that you can only work under the supervision of a Certifier while you hold a Provisional Licence d) understand the licensing year runs from 1 April to 31 March each year, and you must be licensed before 1 April to continue working in the trades each year e) understand that you will need to apply to sit the Advanced Proficiency Assessment, the cost being \$4,490 for one trade/\$8,290 for two trades/\$12,090 for three trades. The APA will take place of over 3 consecutive 8 hour days at an approved training facility, most likely Wintec in Hamilton f) understand that once you have passed the Advanced Proficiency Assessment you can then apply for registration as a Certifier, and this includes supplying current Police Certificates dated within the last 6 months.
